

NOTICE OF INTENTION TO PRESENT PETITIONS FOR PRIVATE BILLS
Parish of Cheam Ward, Sutton, Borough of London

Notice is hereby given that **Lord Lancelot Junior Webb**, of 5 Carisbrooke Court, Station Approach, Cheam, Sutton, England, SM2 7BN, intends to present petitions for Private Bills to the House of Lords during the parliamentary session of January 2025.

The petitions seek to address the following matters:

1. **Authorisation of Prior Petitions:**
To authorise all petitions for Private Bills already submitted to Parliament via **hlprivatebills@parliament.uk** to the House of Lords. These petitions are intended to promote the commencement of operations for **public and private health works**, including services for the **Windrush Generation parishioners** and support for **HL Health Board CIC officers' units and members' units**.
2. **International and Public Inspection:**
To ensure transparency and accessibility on a global scale, public inspection of all relevant documentation, plans, and updates will be made available:
 - Online via the official website: <https://www.houseoflancelot.org/>;
 - At designated physical locations in **England and Wales**, including Sutton Council Offices, Cheam Parish Church, libraries, and community centres;
 - **Internationally**, at selected Commonwealth regional offices and institutions to foster collaboration and accountability among member nations.
3. **Financial Empowerment and Allocation:**
To empower a financial contribution of **£100,000,000** and a January 2025 business start-up instalment of **£84,000,000** to:
 - Improve and manage international, national, and local health and safety planning;
 - Support the construction, development, and maintenance of **commons, community centres, and public health facilities**;
 - Implement robust programs for **environmental, occupational, and mental health and safety**;
 - Develop **learning and training programs** for mental health awareness, safety protocols, and professional development across all regions.
4. **Learning, Training, and Development:**
To prioritise **mental health and safety planning, learning, and training** by:
 - Establishing community-based education and training hubs to provide certified mental health and safety training;
 - Supporting programs for **mental health awareness, stress management**, and psychological well-being in workplaces and communities;
 - Partnering with educational institutions and health organizations for tailored training programs.
5. **Strategic Goals for Commons and Communities:**
To promote sustainable development and better regulation in:
 - **Commons and rural areas**, addressing environmental conservation and public accessibility;
 - Urban and rural **community centres**, ensuring alignment with modern safety and health standards;
 - **Mental health and safety inspections**, improving public confidence and accountability across local and regional levels.
6. **Public Accountability:**
To regulate the issuance of **Exchequer and Treasury Bills** to support these initiatives and to ensure funding transparency. All stakeholders will have access to these records at designated public inspection locations, including international Commonwealth offices.

Stakeholders, parishioners, and the public are invited to review the petitions for Private Bills and submit written representations or objections by the deadline date of **31 January 2025**. Copies of the petitions and associated documentation will be made available for public inspection online and at the specified locations.
